3. No parties have indicated in the shareholders’ circular of the Company dated 26 April 2018 that they intend to vote against or to abstain from voting on any resolutions at the AGM.
4. Computershare Hong Kong Investor Services Limited, the Company’s share registrar, was appointed to act as the scrutineer for the vote-taking at the AGM.
